Decide for yourself, change for yourself: The power of community participation

Community participation entails that the voices and wishes of those involved are always central in each phase of the project. This approach is known as Participatory Planning, Monitoring, Evaluation and Learning (PPMEL). But what exactly does community participation entail? And how can you apply this in your projects? What is Participatory Planning, Monitoring, Evaluation and Learning (PPMEL)?

Since 1990, PPMEL has gained traction within the international development sector. Traditional (Western) evaluation methods are known to ignore and undermine the voice and power of local communities, including the voices of those who are most affected by the projects. PPMEL aims to change this by putting the voice of the community and their knowledge right at the centre. What exactly is PPMEL? At its core, PPMEL refers to the use


of a participatory approach in all phases of the project. From planning, to monitoring, to evaluation, and to learning. Nothing new, then! It has been practised around the world for centuries. But colonisation, globalisation, automatization, and other processes have undermined people's voices. Fortunately, the voice of the community has always remained as long as you
